Leadership in the Face of Challenges: Meeting the Needs of the 21st Century

The world is going digital. Today, everything from education and entertainment to tax forms and job applications occurs online. Yet despite the growing importance of the internet, over 35% of Americans don't have broadband service. This creates a digital divide between those with access and those without. This opening plenary, led by Comcast Corporation Executive Vice President David L. Cohn, will seek to inspire the National Convening participants and set the tone for the rest of the weekend. As the former Chief of Staff to Ed Rendell during his tenure as Mayor of Philadelphia, Cohen will speak about how as leaders in your community you can do something about this by driving broadband adoption to create a platform of inclusion, opportunity and possibility. Leadership in the Face of Challenges: Meeting the Needs of the 21st Century

DAVID COHEN Comcast Corporation

David L. Cohen is Executive Vice President of Comcast Corporation, one of the world's leading media, entertainment and communication companies. He is the majority owner and manager of NBCUniversal. Cohen has a broad portfolio of responsibilities, including corporate communications, government affairs, public affairs and corporate administration, while also serving as senior counselor to the CEO. Before assuming this position in July 2002, Cohen served as partner and chairman of Ballard Spahr Andrews & Ingersoll, LLP, one of the 100 largest law firms in the country.

From January 1992 to April 1997, Cohen served as Chief of Staff to the Honorable Edward G. Rendell, Mayor of the City of Philadelphia. In that role he provided critical support in significant budgetary and financial issues, in economic development activities, in collective bargaining negotiations and in a wide variety of other policy and operational issues.

Cohen serves as Chairman of the Trustees of the University of Pennsylvania and is a member of the Board of Trustees for Penn Medicine — an umbrella governance structure overseeing both the University of Pennsylvania Health System and the University's School of Medicine. Additionly, Cohen serves on the Greater Philadelphia Chamber of Commerce Board of Directors, the national board of the National Urban League, and is a member of the corporate advisory board of the National Council of La Raza. He has served as chair of the University of Southeastern Pennsylvania, chair of the Southeastern Pennsylvania Chapter of the American Red Cross, co-chair of the host committee for the National Conference of Volunteerism and Service and vice chair of the Board of Directors of the Jewish Federation of Greater Philadelphia.

During this session, YEOs will discuss the integrated framework of what households need to achieve financial security and opportunity, examples of ways to integrate and align policies across levels of government, as well as opportunities for better integration and action across sectors.

IDA RADEMACHER

CORPORATION FOR ENTERPRISE DEVELOPMENT (CFED)

Ida Rademacher is the Vice President for Policy and Research at CFED, a national nonprofit based in Washington, DC dedicated to expanding economic opportunity for low-income families and communities. Ms. Rademacher leads CFED's efforts to advance comprehensive policy and research agendas that inform the work of policy makers, advocates and practitioners working to expand economic opportunity and promote asset and wealth building for all Americans. For the past three years, she has been the Director of Research for CFED, where



she led the development of the Assets and Opportunity Scorecard and authored several highly praised research and policy publications. Ms. Rademacher has more than 15 years of experience researching the efficacy of programs and policies that build assets and expand economic opportunities for disadvantaged populations. She graduated from James Madison University with an undergraduate degree in anthropology and economics and received her master's degree in public policy from the University of Maryland.

Growing the Green Economy: Sy Creative Efficiency and Renewable Solutions for Policymakers (*repeated session*)

Want to grow green jobs? Want to build state and local energy independence? Many leaders now recognize that energy efficiency and independence are a viable economic development strategy, and are working to build market demand, financing and the workforce necessary to scale up such programs. This YEO-led session will present insights and recommendations on the economic potential of home energy efficiency, as well as how YEOs can be involved in energy development and the green movement.

DOMINIC FRONGILLO

CAROLINE TOWN COUNCIL

Dominic Frongillo made history when he was elected to the Town Council in Caroline, New York at age 22. He currently serves as Energy Educator for Cornell Cooperative Extension of Tompkins County. Frongillo founded the Tompkins Energy Conservation Corps, which has been recognized by Cornell University president David Skorton as a national model for town-gown collaborations to build a local, sustainable clean energy economy. This model is being adapted in several other cities in New York to harness the power of social marketing in scaling

up home energy efficiency upgrades. In October 2010, Frongillo helped coordinate "Lighten Up Tompkins!" which delivered one energy-saving light bulb to more than 3,500 homes across six towns in just three hours—the largest effort of its kind in New York state. He participated in the United Nations climate negotiations in Bali, Copenhagen and Cancun, and was selected by New York Governor Paterson to help develop New York's far-reaching 2050 Climate Action Plan. Councilmember Frongillo was recently profiled in Liz Walker's book, Creating Sustainable Communities.

SCOTT KAWASAKI

ALASKA HOUSE OF REPRESENTATIVES

Representative Scott Kawasaki broke through barriers when he was elected to the first of two terms on the Fairbanks, Alaska City Council in 1999. He was the youngest ever elected to the position and the first Asian American. Representative Kawasaki was elected to the Alaska State House in 2006 and was the youngest member serving in the state legislature until this past election year. He is a member of the Natural Resources Committee, the Education Committee and the Special Committee on Fisheries. Kawasaki earned his BS in biomedicine from the

University of Alaska Fairbanks. The Representative is an Asian Pacific American Institute for Congressional Studies Fellow and is a recent Marshall Memorial Fellow. He is a current Alumni Council Member of the American Council of Young Political Leaders, having participated in a delegation to Nicaragua and El Salvador in 2001. Kawasaki has also served on numerous boards and commissions and is an avid volunteer at the local level.

The State Fiscal Situation: Clearing Up Misunderstanding and Options for Reform (*repeated session*)

Recent articles about the fiscal situation of states and localities have created the misguided impression that drastic and immediate measures are needed to avoid an imminent fiscal meltdown. These articles mistakenly lump together states' and localities' current, largely recession-related fiscal problems with longer-term issues relating to bond indebtedness, pension obligations and retiree health costs. They also overstate the potential harm caused by long-term fiscal issues such as underfunded pensions. These misunderstandings draw attention away from important issues such as the need to modernize state and local budget and revenue systems. In this workshop, the presenters will address these misunderstandings and offer suggestions for addressing states' structural budget problems.

ELIZABETH MCNICHOL

CENTER ON BUDGET AND POLICY PRIORITIES

Elizabeth McNichol is a Senior Fellow with the State Fiscal Project at the Center on Budget and Policy Priorities in Washington, DC. She specializes in state fiscal issues including the impact of the economy on state budgets, state pension funding, and long-term structural reform of state budget and tax systems. McNichol joined the Center in January 1996. Before coming to the Center, she served as Assistant Research Director of the Service Employees International Union in Washington, D.C. Prior to that, she was a staff member of the Joint Finance Committee for the State of Wisconsin Legislature.

Her research has covered multiple topics related to state fiscal policy, including state taxation of low-income people and state revenue trends. Before joining the Center, Singham worked at a public finance consulting firm. She has a BA in political science from Yale University.

Springwood 1 Criminal and Juvenile Justice at a Grossroads: An Opportunity to Make Public Policy Lemonade Out of Budgetary Lemons?

With ongoing budget difficulties facing most state and local policymakers, many legislators have successfully advanced criminal and juvenile justice reforms that would simultaneously save money and make these systems fairer and more effective. The questions facing us now include: Will these reforms last? Under what circumstances can policymakers advance a more progressive juvenile and criminal justice agenda? And how have policymakers passed or held onto those justice policies that, in the short run, are not revenue-neutral? In this session, directors of the Campaign for Youth Justice and the Justice Policy Institute will discuss their recent research, policy reports, and work in various jurisdictions in areas including



limiting the transfer of youth to adult court and reducing the use of the justice system and incarceration for drug offenses. Participants will be asked to share their successes and the challenges they have faced in passing juvenile and adult justice policies. Finally, they will explore how participants with an interest in justice reform can continue to exchange info and learn from each other moving forward.

CAMPAIGN FOR YOUTH JUSTICE

Liz Ryan brings more than two decades of experience to the Campaign for Youth Justice (CFYJ), an organization she founded that is dedicated to ending the practice of trying, sentencing and incarcerating children in the adult criminal justice system. Prior to starting The Campaign for Youth Justice, Ms. Ryan served for five years as the Advocacy Director for the Youth Law Center's Building Blocks for Youth Initiative, a project to reduce the over-incarceration and disparate treatment of children of color in the juvenile justice system. Her work at the Youth

Law Center involved campaign advocacy assistance at the national, state and local levels to stop punitive juvenile justice legislation, redirect funding to communities, and increase involvement of the constituencies that were most affected by juvenile justice decision-making.

BALTIMORE ALGEBRA PROJECT

Maryland Shaw is a youth organizer for the Baltimore Algebra Project, a democratic, studentrun and organized program mainly focused on the one-on-one tutoring of math at the middle and high school levels. Shaw is also a coordinator for the Alliance for Educational Justice, a national alliance of youth organizing and intergenerational groups working for educational justice. Shaw is a sophomore at Morgan State University, majoring in English. She aspires to be an English teacher in the Baltimore City and New York City school system.


TRACY VELÁZQUEZ

JUSTICE POLICY INSTITUTE





She is the founder and Chairman of the Dwight Central Management Team Youth Concerns Committee, with the goal of exposing youth to positive experiences. Alderwoman Calder is also co-founder and an executive committee member of The CALLED, a Connecticut-based organization of young professionals of African descent that focuses on meeting the needs of the state's urban areas.

She is an administrative fellow with the Yale New Haven Health System and a Connecticut Health Foundation leadership fellow. She received her bachelor's degree in psychology and MPH from Yale University.

KAREN LIOT HILL

LEBANON CITY COUNCIL

Karen Liot Hill is a City Councilor in Lebanon, New Hampshire. She was elected to represent her ward in 2005, defeating an incumbent Councilor with nearly two-thirds of the vote. After spearheading the city's first-ever strategic planning effort in 2006, she was re-elected to the ward seat in 2007. She was appointed by her colleagues on the Council to serve a one-year term as Mayor in 2008, where she broke with tradition and served as a visible and active mayor, advocating for the people of Lebanon with state and federal officials and focusing

on community outreach and engagement. In 2009, she was re-elected to the City Council—this time to an at-large seat—with 76% of the vote. In addition to serving her community on the city council, she also sits on the boards of WISE, a non-profit organization serving victims of domestic and sexual violence, and Vital Communities, which seeks creative solutions to regional challenges. She is a member of the New Hampshire Democratic Party's State Committee and recently co-chaired the NHDP state convention.

ANGELA GARRETSON

HILLSIDE CITY COUNCIL

Councilwoman Angela R. Garretson is an at-large member of the Hillside City Council in New Jersey. Prior to her election in 2009, Garretson was president of the School Board and served as a member for the last five years, where she worked with students, parents, community leaders, local and state government and non-profit organizations to preserve and strengthen quality education in her community. Previously, Garretson worked for the Eagleton Institute of Politics, as well as several community organizations and political campaigns. She graduated

from Syracuse University with Bachelor of Science in Business Communications and from Rutgers University with a Masters in Public Policy and Administration. Garretson is currently obtaining her PhD.

United States Secretary of Education, The Honorable Arne Duncan

Under the leadership of President Barack Obama, there has been an unprecedented focus on investing in, improving and sparking innovation in public education. This session will feature the United States Department of Education Secretary, Arne Duncan, who will update YEOs on the effort to reauthorize ESEA (formerly known as No Child Left Behind) and other initiatives of the current administration to prepare America's students for college, career and life. He will also discuss the roles that local and state level Young Elected Officials can play in these reforms. Expect this session to be interactive and informative, as YEOs will have the opportunity to participate in a question and answer period with Secretary Duncan and highlight what's happening in communities across the nation.

ARNE DUNCAN U.S. Secretary of Education

Arne Duncan was nominated to be secretary of education by President Barack Obama and was confirmed by the U.S. Senate on January 20, 2009.

In his confirmation hearings, Duncan said education is "the most pressing issue facing America," adding that "preparing young people for success in life is not just a moral obligation of society" but also an "economic imperative." Duncan expressed his commitment to work under the leadership of President Obama and with all those involved in education "to enhance education in America, to lift our children and families out of poverty, to help our students learn to contribute to the

civility of our great American democracy, and to strengthen our economy by producing a workforce that can make us as competitive as possible."

Prior to his appointment as secretary of education, Duncan was appointed by Mayor Richard M. Daley to serve as the chief executive officer of Chicago Public Schools (CPS). As CEO, Duncan's mandate was to raise education standards and performance, improve teacher and principal quality and increase learning options. In seven and a half years, he united education reformers, teachers, principals and business stakeholders behind an aggressive education reform agenda that included opening more than 100 new schools, expanding after-school and summer learning programs, closing down underperforming schools, increasing early childhood and college access, dramatically boosting the caliber of teachers and building public-private partnerships around a variety of education initiatives.

Prior to joining Chicago Public Schools, Duncan ran the non-profit Ariel Education Initiative, an education foundation which helped fund college for a class of inner-city children under the I Have A Dream program. He was part of a team that later started a new public elementary school built around a financial literacy curriculum, the Ariel Community Academy, which today ranks among the top elementary schools in Chicago.

Dare to DREAM: Surveying the **Current Immigration Reform Landscape**

President Obama recently called the need for comprehensive immigration reform an economic, security and moral imperative for the "millions who live in the shadows." YEOs have a unique opportunity to make lasting, significant and progressive change. While this is a national issue, policy shifts at the state and local level have a significant impact on the lives of immigrants. In this session, immigration policy experts will provide an overview of the current immigration reform landscape, as well as share local and state policies that encourage integration, promote economic justice and growth, and protect the rights of immigrants of all nationalities.

SUMAN RAGHUNATHAN

PROGRESSIVE STATES NETWORK

Suman Raghunathan, Immigration Policy Specialist with the Progressive States Network, leads the organization's work on immigration policy and has deep experience advancing immigrant rights via grassroots, advocacy and policy organizations. The daughter of Indian immigrants and the former Interim Executive Director of Chhaya Community Development Corporation, Raghunathan's expertise lies in crafting policy platforms and advocacy strategies. She has also developed programs to engage immigrants in the electoral process at the NY

Immigration Coalition and OneAmerica, including managing the nation's largest voter registration project for new citizens. Most recently, Ms. Raghunathan was an immigration policy consultant, developing progressive policy agendas for Demos and the Drum Major Institute. She holds a bachelor's degree in international relations from Brown University and a master's degree in nonprofit management from Milano - The New School for Management and Urban Policy.

Joanne Lin has served as legislative counsel with the ACLU Washington Legislative Office since 2007. She works with Congress and executive agencies on a broad range of immigration and human rights issues including racial profiling, state and local immigration enforcement, access to higher education, immigration detention conditions, sexual assault in immigration detention, immigration due process, access to counsel, border enforcement and excessive use of force by border patrol. Prior to joining the ACLU, Lin directed immigration policy at

Legal Momentum's Immigrant Women Program in Washington, DC. She was a principal drafter of the immigration provisions of the Violence Against Women Act of 2005. Previously, she practiced immigration law at Van Der Hout, Brigagliano & Nightingale, one of the nation's premier immigration law firms and worked at Bay Area Legal Aid. Lin also clerked for the Honorable Shirley S. Abrahamson, Chief Justice of the Wisconsin Supreme Court.

Corporate Power, Corporate Personhood, and the Corporate Court: A Discussion of Citizens United and Its Aftermath

Session

Over the past several years and continuing to the present, the dangerously conservative Roberts Court has regularly bent the law, ignored precedent and turned logic upside-down in order to strike down Americans' efforts to impose reasonable checks on corporate power. Perhaps the most notorious example was last year's Citizens United case, where a sharply divided Supreme Court ruled that giant corporations have the same First Amendment rights as people to engage in political speech. This had a deleterious impact on the 2010 elections. In this session, YEOs will learn about different efforts to amend the Constitution – either to specifically reverse Citizens United or, more expansively, to abolish corporate personhood in general. YEOs will also discuss remedial legislation that could mitigate the impact of the Supreme Court's decisions short of a constitutional amendment.

JOHN C. BONIFAZ

FREE SPEECH FOR PEOPLE

John Bonifaz is co-founder and director of Free Speech for People, a national, non-partisan campaign seeking to restore democracy to the people through a constitutional amendment, designed ensure that government represents the people's interests, and not just corporations. Bonifaz has worked as legal director of Voter Action, a national voting rights and election integrity organization in the United States, and as executive director and general counsel of the National Voting Rights Institute (NVRI). Bonifaz has been at the forefront of key voting

rights battles in the United States for nearly two decades—pioneering a series of court challenges that have helped to redefine the campaign finance question as a basic voting rights issue of our time. He led the fight in the federal courts for a recount of the 2004 presidential vote in Ohio, and prevailed in federal court in Pennsylvania on the eve of the 2008 election to ensure that Pennsylvania voters would receive emergency paper ballots when they faced long lines caused by voting machine breakdowns. Bonifaz is a 1992 cum laude graduate of Harvard Law School.

JAMIE RASKIN

MARYLAND STATE SENATE

Jamie Raskin is a state senator in Maryland and a professor of constitutional law at American University's Washington College of Law (WCL). A progressive state senator who came to office in 2006 in a landslide upset victory against a 32-year incumbent in the primary, Senator Raskin has twice been elected with more than 99% of the general election vote. Raskin is the Director of WCL's Program on Law and Government and an accomplished author. Raskin's books include Overruling Democracy: The Supreme Court versus the American

People (2003), a bestselling analysis of Bush v. Gore and right-wing judicial activism, and We the Students (3d ed. 2008), which examines cases affecting America's students and has been called "the bible of the new movement for constitutional literacy." Raskin founded the Marshall-Brennan Constitutional Literacy Project, which has sent more than a thousand law students from various law schools into public high schools across the country to teach a course in constitutional literacy. Raskin is also a Senior Fellow at People For the American Way.

During this plenary, the president of the Service Employees International Union, Mary Kay Henry, will help outline the historic triumphs of organized labor, as well as provide insights and recommendations on strategies to both protect and grow the labor movement in states and communities.

MARY KAY HENRY Service Employees International Union (SEIU)

In 2010 Mary Kay Henry was unanimously elected to serve as International Executive President of Service Employees International Union (SEIU), a 2.2 million-member union of health care workers. She was named one of the nation's "Top 25 Women in Healthcare" by Modern Healthcare in 2009. For nearly 30 years, Henry has represented health care workers at SEIU, where she helped lead the fight to expand health care for millions of children and strengthen the State Children's Health Insurance Program. Henry has devoted her life to helping America's health care workers form unions, improve their jobs and the quality of care, and advocate for a more rational and humane health care system. Henry



began working with SEIU in 1979 and rose to become a leader and chief health care strategist. She was elected to the international executive board in 1996, and in June 2004 she was elected to serve as an international executive vice president of SEIU, leading the union's efforts to build a stronger voice for health care workers.

An active champion of health care reform, Henry envisions a U.S. health care system that provides universal coverage and gives front-line caregivers a real voice in patient care. Recognizing that today's global economy demands a new and different model of labor-management relationships, Henry is leading a national effort by SEIU to build new kinds of partnerships with hospital employers—partnerships that will improve the quality of patient care, strengthen the hospital's competitive performance and give workers a voice in decisions that affect care and working conditions.

In her first term in the legislature, she fought for a variety of social justice issues including women's rights, LGBT rights, workers' rights, immigrant rights and for a fair and open redistricting process. Senator Buhl has consulted with a variety of non-profits, and currently works as the executive director of a youth advocacy organization and serves on the heard of NARAL Pro-Choice South Dakot

TISHAURA O. JONES

MISSOURI HOUSE OF REPRESENTATIVES

Representative Tishaura Jones is currently serving her 2nd term in the Missouri House of Representatives. She is the first African-American and the first woman in Missouri history to hold the position of Assistant Minority Floor Leader. As a member of the leadership team, she is the second in command among her party members of the Missouri House of Representatives. Rep. Jones has a master's degree in health administration from the Saint Louis University School of Public Health and has a bachelor's degree in finance from Hampton University.


NANCY KEENAN

Voting Reform and Redistricting: Meeting the Needs of an Increasingly Mobile Electorate and Protecting Communities of Interest

Trainers from the Fair Elections Legal Network and the Southern Coalition for Social Justice will review some of the voting reform issues being seen across the country. The trainers will discuss how new voting-related legislation being pushed in state legislatures are affecting various voting reform efforts. Particular emphasis will be paid to common election administration issues that disenfranchise voters, as well as traditional laws and practices that no longer meet the needs of an increasingly mobile electorate. Trainers will also discuss the impact of new laws and voting reform efforts on the redistricting process. The twin goals of the session are to help elected officials and their constituents overcome these challenges by providing tips to ensure that voter registration and GOTV efforts account for likely obstacles and to recommend legislative and administrative reforms.


INEKE MUSHOVIC

National Security Communications: **Effectively Connecting through Emotion and Non-Verbal Cues**

National Security Communication is a program designed to enable young leaders to communicate their views on national security to their constituents in a credible and effective way. It attempts to combat the impression that progressives are weak on national security by teaching young progressive policymakers how to conduct themselves effectively with regard to national security. The presentation stresses the importance of emotional connection to the constituents, as well as methods for good nonverbal communication and media interviews. In the first segment of NSC, the presentation deals with talking to people who disagree with or are ambivalent about the elected official's opinion or policy, using the counterintuitive process of emphasizing feelings over facts and values over policies in order to persuade. The section on nonverbal communication is a lesson in how to project strength without being aggressive. In dealing with media interviews, our program discusses various strategies for communicating effectively and likably in front of an audience.

MICHAEL MOSCHELLA

TRUMAN NATIONAL SECURITY PROJECT

Michael Moschella currently serves as political director for the Truman National Security Project, primarily managing political training programs. With the Truman Project, he has trained hundreds of elected officials, candidates for federal, state, and local office, Congressional staffers, political consultants, and progressive activists. Recently, Moschella launched the Truman Project Partners, a first-of-its-kind national security training program specifically for campaign and advocacy professionals. He previously served as a leading campaign consultant

with specific expertise in large-district voter targeting, grassroots field mobilizations and online political organizing. Moschella has consulted with and managed Congressional campaigns in Florida and Massachusetts, a Gubernatorial race in Massachusetts and state-level races in both California and Massachusetts. In 2004 and 2005, he worked with the New Democrat Network (NDN) on a variety of projects including: creation of the New Politics Institute, a think tank for new political strategy; NDN Hispanic Project, then the largest Spanish-language political ad campaign in U.S. history; Restoring America's Promise campaign, which promoted progressive values in red states; and NDN-PAC, a fundraising organization for 40 U.S. Representatives and 18 Senators.

What elected officials say often represents what they stand for, and comes to define their work and public image. Therefore, it is imperative that they frame their message strategically and appropriately. In this general plenary, pollster Celinda Lake will discuss how to effectively talk about progressive issues in a way that resonates best with the American public – particularly about the economy, job creation, unions, health care and good government. Additionally, there will be a discussion of recent polling, research and the types of messaging language YEOs should be using in their communities.

CELINDA LAKE Lake Research Partners

Celinda Lake is one of the nation's leading political strategists. Her firm, Lake Research Partners, is known for cutting-edge research on issues including the economy, health care, the environment and education. She has worked for many organizations including the White House Project, AFL-CIO, SEIU, Human Rights Campaign, EMILY's List, the Kaiser Family Foundation and the Democratic National Committee.



Since its formation, Lake Research Partners has become one of the most respected polling firms in the country. Lake Research Partners has a long history

of successful initiative campaigns. In 2008 Lake polled in California to beat parental notification initiatives three times in a row. In 2006 she helped with successful minimum wage campaigns in five states and was the pollster on the first successful effort to defeat an anti-gay marriage initiative in Arizona.

Lake has a long record of defeating incumbents and was an integral part of the successful partisan effort to take control of the House of Representatives in 2006. She is one of the nation's foremost experts on electing women candidates and on framing issues to women voters. She is renowned for her groundbreaking research on single women voters and has helped elect numerous female candidates, including Senator Barbara Mikulski, former Arizona Governor Janet Napolitano, Senator Blanche Lincoln, Patricia Madrid (the first Hispanic woman Attorney General in New Mexico) and Senator Carol Moseley-Braun.

Prior to forming Lake Research Partners, Lake was partner and vice president at Greenberg-Lake. Her earlier experience includes serving as political director of the Women's Campaign Fund, research director at the Institute for Social Research in Ann Arbor, Michigan, and as policy analyst for the Subcommittee on Select Education. Lake holds a master's degree in political science and survey research from the University of Michigan at Ann Arbor and a certificate in political science from the University of Geneva in Switzerland. She received her undergraduate degree from Smith College in Massachusetts.

DANIELLE IMANI ASAKO ADAMS

Soil and Water Conservation District Supervisor Durham, North Carolina

Danielle Imani Asako Adams is a senior at North Carolina Central University pursing a degree in Political Science with minors in German and Music. In 2008, at the age of 24, she became the youngest elected official in Durham County, garnering 46 percent of the vote as the Durham County Soil and Water Conservation District Supervisor. Prior to holding elected office, she served as HBCU Caucus Chair and as Director of Membership for the North Carolina Federation of College Democrats. In addition, Supervisor Adams serves as a member of NCCU's College

Democrats Chapter, Political Science Club, the NCCU NAACP, and the NCCU Civic Engagement Task Force. Supervisor Adams has worked with the International Affairs Council and the Middle East Partnership Initiative of the U.S. Department of State, hosting a delegation of eight Middle Eastern women from the nations of Yemen, Morocco, Lebanon, and Saudi Arabia.

MARCUS AFZALI

CITY COUNCILMEMBER

College Park, Maryland

Marcus Afzali was elected to the College Park City Council in 2009, when he successfully defeated two incumbents and received 73% of the vote in an election marked by unusually high voter turn out. Afzali was the first student ever to run a successful race for the College Park City Council. He received a Bachelor's Degree in Political Science from California State University, Northridge and has a Masters Degree in International Relations from the University of Maryland. Councilman Afzali currently works as a 401k specialist for T. Rowe Price. He has initiated a monthly event

to promote shopping locally in College Park, which brings people together from throughout the city with guest speakers ranging from local elected officials to Minority Whip Steny Hoyer.

FELIPE AGREDANO- LOZANO

COUNTY COMMISSIONER

Los Angeles, California

Felipe Agredano-Lozano is currently serving on the Los Angeles County Commission on Human Relations, where he has served as President of the Board. Agredano-Lozano was a Teaching Fellow at Harvard before returning to his native state of California, where he served as an aide to State Sen. Rev. Dr. Jack Scott. Commissioner Agredano-Lozano has served on numerous boards, including the Muscular Dystrophy Association and the California Latino Legislative Caucus Madrinas & Padrinos Program. He previously served as President of The UC Berkeley Chicano

Latino Alumni and of the Eastside Democratic Club, which represented the greater East Los Angeles area and honored him as "Democrat of the Year." The government of Spain named him "Young Hispanic American Leader" in 2001, and the California State Legislature presented him with a California State Resolution in 2008. 

David Carlucci was elected Senator for New York's 38th district in November 2010, becoming the youngest member of the state Senate. Sen. Carlucci previously served three terms as Town Clerk of Clarkstown, where he advanced the town's technological infrastructure by digitizing hundreds of thousands of records, improved accessibility to local government by staggering office hours and created a "mobile office" which brought town clerk services directly to the citizens. 



and a bachelor's degree in Finance from Hampton University. She has more than ten years of healthcare experience working in hospitals and community health centers. Currently, Rep.


Jones is the Vice President of Public Finance at Blaylock, Robert, Van, LLC, the third largest minorityowned investment banking firm in the county.

MICHAEL MATURO TOWN COUNCILMEMBER


TAPPAN, NEW YORK

AMANDA MCGILL




LINDA INGE
