







#### **Nationwide Networking**





Currently, she works as National Legislative and Organizing Director at 100% Democracy: An Initiative for Universal Voting, where she is leading efforts to advance 100% voting participation conversation and legislation in localities, states and nationally. Previously, Raaheela worked as Deputy Director of Fair Elections Center's Campus Vote Project, a nonprofit that focuses on institutionalizing voting and civic engagement at 300+ college campuses across the country, and Manager of Leadership Programs at New American Leaders, where she cultivated and supported a national network of 500+ first- and second-generation immigrant elected officials. As a young, first-generation American Muslim woman of Indian and Pakistani descent, Raaheela understands and passionately strives for equity and justice for marginalized people and communities.



#### Natalie Austin

Natalie Austin is a Civics Outreach Manager at Google, where she focuses on teaching best practices across Google products and tools. A Miami native, Natalie now lives in Washington, DC. Her past roles include stints on the Biden-Harris campaign, the White House, and TikTok.



#### Megan Bellamy

Megan Bellamy serves as Vice President of Law and Policy at Voting Rights Lab - a nonpartisan organization accelerating the movement for free and fair elections through expert analysis, research and innovations. She is a political strategist, attorney, and voting rights advocate with a passion for protecting and expanding the right to vote. Megan has served in various leadership roles with municipal, state, and federal campaigns, and as the Director of National Programs for Verified Voting where she supported the work of computer scientists, election officials, and local advocates to protect voting rights by promoting the responsible use of technology in elections. Megan earned a BA in English from the University of Florida and a JD from Howard University School of Law. She lives in North Carolina with her husband and three children.



#### **Dwight Bullard**

State Senator Dwight M. Bullard hails from an esteemed educator, community activist and legislator family. In 1981, Dwight moved to Miami. After graduating high school, he continued his education at Florida A&M University where he received his B.S. in History Education. From 2000 to 2017, Sen. Bullard was a teacher at Coral Reef Senior High School and in 2008 he was sworn into office as representative of District 118. In 2012 Senator Bullard was elected to the Florida Senate. In his time in the Senate, Bullard worked to stop online bullying, bring tuition equity to aspiring citizens and raise the minimum wage. Bullard served in the Florida Senate until 2016. In 2017, Bullard was hired as Political Director of the New Florida Majority and recently became Senior Political Advisor of the newly formed Florida Rising. In 2019, he became President of the South Dade NAACP.





#### **Tracie Ching**

Tracie Ching is an artist working in D.C., best known for her cross-hatching style. Ching first found her niche in pop-culture creating alternative movie posters. She has since grown her portfolio to include art for Hasbro and Penguin Randomhouse, covers for TIME, and key art for Disney and Marvel Studios. Ching is also known for her political work including the 2021 inauguration poster for President Joe Biden, viral KavaNope poster and voting initiatives like Michelle Obama's When We All Vote. She is often engaged on social justice campaigns including Smokey the Bear, the Equal Rights Amendment, and National Geographic's Campaign for Nature. Ching's work has been shown in the Getty and Design Museum and is in the permanent collection of The Library of Congress and Frank Lloyd Wright Foundation. She is founder and principal mentor of the biennial We Create mentorship program which empowers emerging visual artists of minoritized identities.



#### **Quantá Crews**

Rev. Quantá Crews is a community advocate and an associate minister at the Historic Tanner Chapel African Methodist Episcopal Church in Phoenix, AZ. She serves as coordinator of the No Limits Special Needs Ministry and the regional Richard Allen Young Adult Council. #### **David Crowley**

In May of 2020, David Crowley became the youngest county executive in the history of Milwaukee County and the first Black leader elected to serve in the role. On April 2, 2024, County Executive Crowley was reelected to a second term with 85% of the vote. David is focusing Milwaukee County on a vision of achieving racial equity, and by doing so, becoming the healthiest county in Wisconsin. Under his leadership, Milwaukee County has diversified positions, streamlined government services, addressed legacy fiscal challenges, and delivered investments that are moving the community forward. The fundamental tenet of Executive Crowley's administration is to build bridges that bring people together, deliver prosperity for working families, and foster a safer, stronger, and healthier Milwaukee County. David attended Bay View High School and is currently finishing up his degree at UW-Milwaukee. He lives in Milwaukee with his wife, Ericka, and their three young daughters.

Canek has focused on increasing housing opportunities, investing in public schools and transportation infrastructure, eliminating health inequities, and making government more accessible and accountable.



#### Elizabeth Alcantar

In November of 2018, Elizabeth was elected to the Cudahy City Council and consequently named Vice Mayor, making her the city's youngest vice mayor. The following year she served as Mayor in an unprecedented year where Elizabeth led her city through the Delta fuel dump and the global coronavirus pandemic. She's honored to serve the community that raised her and is focused on housing, increasing civic engagement, access to quality green space and environmental justice, and supporting Cudahy's women and girls. Elizabeth works for the Coalition for Humane Immigrant Rights (CHIRLA) where she strives to educate and organize the community on the issue of immigration and ensures immigrant community members from Northeast L.A. to Southeast L.A. know their rights and feel confident in their fight for achieving a just society for all, regardless of status.



#### **Dan Arriola**

Councilmember Dan Arriola was first elected to the Tracy City Council in 2018 and then re-elected in 2022. At 29-years-old, he became the first Millennial Councilmember, as well as the first openly LGBTQ elected official, in the history of the City of Tracy. Arriola was first elected to office as a Tracy School Board Trustee in 2016. He also works as a Deputy District Attorney for San Joaquin County. As a councilmember, Arriola has championed various policy initiatives including: opening the city's first public homeless shelter; raising the Pride Flag for the first-time ever; legalizing commercial cannabis; approving the first affordable housing development in over 20 years; and passing an equity business license tax. Arriola has also been recognized on the Young Elected Officials "35 Under 35" List by the YEO Network and on the "40 Best LGBT Lawyers Under 40" List by the National LGBT Bar Association.



#### **Ethan Ashley**

Ethan Ashley, co-Founder and co-CEO of School Board Partners, is dedicated to fostering anti-racist leadership in education. His impact spans over 250 elected school board members across 70 districts in 25 states, representing over 5 million students. Through SBP, Ethan has facilitated the passage of 100+ policies, surpassing national averages in representation and reelection rates. With two terms on the Orleans Parish School Board, including as President during tumultuous times marked by racial reckoning, natural disasters, and the pandemic, Ethan demonstrates commitment to community resilience. Beyond board service, he contributes to organizations like the National Juvenile Justice Network and the New Orleans Regional Leadership Institute. His legal background and civil rights advocacy, evidenced by roles at esteemed organizations like the Urban League and Anti-Defamation League, underscore his dedication to equity and justice. #### Elizabeth Bennett-Parker

Elizabeth Bennett-Parker is the Delegate for the 5th Virginia House District, located in Alexandria. Elizabeth is the fifth member of the House of Delegates to give birth while in office (in 405 years), and she is committed to supporting children and families. She has championed early childhood education, school meals for all, and measures to help families remain housed. She has also carried and passed bills to enhance voting rights and disability rights, improve access to participation in government through virtual meetings and remote participation, and strengthen protections for survivors of domestic violence and stalking. Elizabeth serves on the House Finance, General Laws, and Counties, Cities & Towns Committees. She previously served as the Vice Mayor of Alexandria and as a coleader of Together We Bake, a non-profit job training and personal development program for underserved women. She lives in Alexandria with her husband, daughter, and their rescue cat and dog.



#### **Ethan Bertrand**

Ethan Bertrand is an elected official and public policy professional. He currently serves as a School Board Member for the Goleta Union School District and as a District Director for the California State Assembly. Previously, Ethan was elected to serve as Director of the Isla Vista Community Services District (2017-2022) and Director of the Isla Vista Recreation and Park District (2015-2016). He also worked for the Santa Barbara County Board of Supervisors, focusing on criminal justice, mental wellness, racial equity, and homelessness. Ethan is a graduate of the University of California, Santa Barbara. Beginning in 2025, he will attend the Goldman School of Public Policy at the University of California, Berkeley. He enjoys practicing yoga, distance running, playing music, and watching sunsets from the beaches of Isla Vista and beyond. Ethan is a proud member of the LGBTQ community.



#### **Jasmine Bowles**

Jasmine Bowles is an elected board member representing District 1 of Clayton County Public Schools. Jasmine began her career as a teacher, but has also worked as an administrator, policy analyst, realtor, non-profit executive and founder. In addition to her local organizing efforts to end educational inequity, Jasmine has coached hundreds of teachers, policy fellows, non-profit leaders, and school board members across the country. Currently, Jasmine serves as the Georgia State Director for Care in Action, where she fights for women of color & care workers through advocacy, lobbying and legislation.



#### **Spencer Brandt**

Spencer Brandt was elected to the Isla Vista Community Services District Board of Directors in 2016, and re-elected in 2022. Spencer moved to the college community of Isla Vista to attend UC Santa Barbara, and quickly began organizing to register voters ahead of the 2016 election. He was first elected while a second year undergraduate student, and served as Board President from 2019-2022. During his time in office he has worked to support survivors of sexual violence with trauma-informed services, enhance safety through lighting infrastructure and enhanced unarmed safety personnel, and opening the first Isla Vista Community Center. In addition to his elected role, Spencer works as legislative staff for Santa Barbara County Supervisor Das Williams, handling housing, homelessness, behavioral health, and emergency preparedness.





#### **Winsvey Campos**

Winsvey (wins-vay) Campos, represents Oregon Senate District 18. She was raised in a low-income household in a rural community by a single, immigrant father. This upbringing fueled her passion for addressing societal disparities. Making history, she became the youngest woman elected to the Oregon House of Representatives in 2020, and in 2022 was elected as the youngest person to ever serve in the Oregon State Senate. Alongside her legislative role, Campos has previously worked as a housing case manager and currently works to support school-based health systems. She has ardently championed progressive policies to support vulnerable Oregonians including expanding healthcare access, combating food insecurity, and tackling housing instability. As the former Vice Chair of the House Housing Committee, she helped allocate substantial funds into communities to help combat the housing crisis. As the current co-chair of the Ways and Means Human Services subcommittee, she prioritizes investments in behavioral health, community-based care, and early childhood resources.



#### **Park Cannon**

State Rep. Park Cannon serves the citizens of Georgia's House District 58, which encompasses a diverse cross-section of 20 neighborhoods within intown Atlanta. She was awarded the 2021 Legislator of the Year by the National Black Caucus of State Legislators. Her legislative efforts focus on reproductive justice issues, access to quality healthcare, housing, and education. She also devotes her legislative work to protecting Georgia's most vulnerable: women and children, the elderly and the LGBTQIA+ community. Rep. Cannon attended the University of North Carolina at Chapel Hill, where she earned a Bachelor of Arts in Hispanic Linguistics and a Bachelor of Arts in Linguistics, and minored in Women's and Gender Studies. Her Executive Education was completed at the Harvard Kennedy School of Government on the subject of police accountability and voting rights. She was unlawfully arrested in March of 2021 upon knocking on the Governor's door to protect voting rights.



#### **Kevin Carter**

Kevin L. Carter is a distinguished leader in the field of education, having recently served as a Director and First Vice President of Pittsburgh Public Schools. With a passion for empowering students and improving academic outcomes, he has dedicated his career to creating positive change in the education system. In addition to his role in public education, Kevin is also the First Vice President and Founder of the Adonai Center, a non-profit organization that provides resources and support to underprivileged communities. Through his work at the Adonai Center, Kevin has made a significant impact on the lives of countless individuals, helping them access the tools and opportunities they need to thrive. Kevin's commitment to education and community service is evident in everything he does. He is a tireless advocate for educational equity and social justice, and he continues to work towards creating a more inclusive and equitable society for all.





#### **Andres Castillo-Quintana**

Andres Castillo-Quintana, a Peruvian American elected official, made history at age of 25 when he became the first Latino and openly gay council member in the Town of Bedford, NY. He holds a bachelor's in psychology and certificate in global health and health policy from Princeton University, currently pursuing a master's in public administration at Columbia SIPA. Before entering the political arena, he worked at one of the largest federally qualified health centers in the Hudson Valley, enabling him to address systemic barriers to care through program management, community outreach and patient advocacy. He was ultimately inspired to run for office because of the broken systems and growing inequities that his patients were facing. This, coupled with the lack of diverse representation in politics, ignited his grassroots campaign to ensure that local government is both rooted in public service and fully attuned to the needs and values of all communities.



#### **Savion Castro**

Savion Castro is the youngest person ever to serve on the Madison Metropolitan School District Board of Education. He is the operations workgroup chair, overseeing an over \$500 million budget process, district policies, operations, and building services. During his time on the board, MMSD passed a historic \$317 million referendum, expanded early childhood education, arts programming, and worked to dismantle the school-to-prison pipeline. In addition to serving on the Board of Education, Savion is a teacher and student mentor for First Wave hip-hop and urban arts scholarship program in UW-Madison's office of multicultural arts and initiatives. Savion is a doctoral candidate at UW-Madison's education leadership and policy analysis, as well as an education fellow with the Interdisciplinary Training Program in Education Sciences program at the Wisconsin Center for Education Research.



#### Alan Cavagnaro

Alan Cavagnaro, a first-generation student from the University of Connecticut, is a dedicated public servant and elected commissioner on the Planning & Zoning Commission in South Windsor, CT. Elected at 19 years of age in 2021, he became Connecticut's youngest zoning commissioner. Alan focuses on expanding affordable housing, preserving open spaces, increasing EV charging stations, updating outdated regulations, and holding developers accountable. He interned for YEO Network alum, the late State Rep. Q Williams in 2022, helping pass the Fair Rent Commission bill during his time interning in the state house. Currently, Alan is the Campaign Coordinator for DesegregateCT, which advocates for Pro-Homes reforms in one of the most segregated states in America. He also serves as the 2nd Vice-Chair of the South Windsor Democratic Town Committee, making him one of the youngest EBoard officers in the state for local DTCs.



#### **Mark Chambers**

Mark Chambers, Jr. was elected Alderman on November 8, 2022 and reelected in April 2024. Early on in his life, Mark learned firsthand the importance of being a leader and in mentoring others by participating in youth programs. Mark attended Milwaukee Area Technical College & served as Vice President of the Black Student Union & then moved on to a business degree from Concordia University. Mark excelled in the finance industry as Market President. Professionally, Mark is a member of the Greater Milwaukee African American Business Resource Group (GMAABRG) and an advisor for Wisconsin Governor's Financial Literacy Council where he continues to teach financial literacy courses.





#### Chelsea Cook

Chelsea Cook currently serves as a Ward representative on the Durham, North Carolina City Council. Concurrently, Cook practices as an attorney with Legal Aid of North Carolina's Eviction Diversion Program, representing low-income tenants facing eviction in court. Cook has a J.D. from Stanford University School of Law and a B.A. from the University of North Carolina at Chapel Hill. Originally from Memphis, Cook has long been interested in civil justice and grassroots advocacy. In what little spare time Cook has outside of their jobs working with their beloved Durham community, Cook enjoys outdoor rock climbing, gardening, and baking, along with spending time with their partner and friends (and Sparrowhawk the dog).



#### **Jessica Davis**

Commissioner Jessica Davis was elected to Seat 3 on the DeLand City Commission on August 26, 2014, making her the first African American female to be elected to The DeLand City Commission. Commissioner Davis is now serving in her 3rd term on the DeLand City Commission. Davis understands the sense of urgency needed in serving the citizens of DeLand and has a vested interest in her community. Understanding how economic development is directly related to communities and schools is vital to short and long-term success. Davis understands such interrelationships and has ensured to the best of her ability that the citizens of DeLand are provided the best quality of life for themselves and their family. Commissioner Davis is a graduate of Florida Agricultural and Mechanical University where she earned her Bachelor of Science Degree in Broadcast Journalism and minor in education. She received her Master's Degree in Education from Stetson University.



#### Natasha Dupee

Natasha Dupee is completing her second term as DC Advisory Neighborhood Commissioner (ANC) for Single-Member District 7E04 where she also serves as the Commission's Chair and previously led their Education Committee. As ANC, she has spent the past three years building shared knowledge to steward the vision for the redevelopment of the 4th largest parcel of redevelopment in the city. A fifth-generation native Washingtonian, she is committed to creating and defending policies that increase access to a quality life. Professionally, Mayor Muriel Bowser appointed Commissioner Dupee to the Mayor's Office on Women's Policy and Initiatives in 2022 where she now leads as the Executive Director. Commissioner Dupee is a double alumna of the George Washington University with a bachelor's in women's studies and a master's in public health policy. #### Michalyn Easter-Thomas

Michalyn Easter-Thomas is an educator, community advocate, and currently serves as the Memphis City Councilwoman for District 7. As the youngest African American to ever be elected to the Memphis City Council in 2019, Michalyn is proud to work alongside her colleagues to make Memphis a more equitable place to live. Her current push for equity focuses on economic access for all, community development in our historically underserved neighborhoods, and the support of youth initiatives across the city.





#### **Cobi Frongillo**

At 23, Cobi Frongillo was the youngest-ever Town Councilor to be elected in the Town of Franklin, Massachusetts. Now 26, Cobi serves as Chair of the Town's Arts & Culture Committee, Vice Chair of the Economic Development Subcommittee, and Vice Chair of the Master Plan Committee. In Town, Cobi also serves in leadership roles for Greater Attleboro & Taunton Regional Transit Authority, Building Equitable Neighborhoods for Franklin, Franklin & Bellingham Rail Trail Committee, Franklin Freedom Team, and SAFE Coalition. Cobi is a member of Elected Officials to Protect America's National Leadership Council and Progressive Mass' Progressive Municipal Leaders Network. During the day, Cobi serves as the Deputy Director of Renewable & Alternative Energy for the Massachusetts Department of Energy Resources. He earned his Master of Public Policy from the University of Massachusetts Amherst and a Graduate Certificate of Public Leadership from the University of San Francisco.



#### **Dominic Frongillo**

Internationally-recognized advocate and public servant Dominic Frongillo is the youngest person ever elected to the Town Council in Caroline, New York, elected at age 22. An award-winning changemaker, Dominic co-founded Elected Officials to Protect America, a nonpartisan network of more than 2,000 state and local lawmakers in all 50 states to solve the climate crisis and ensure environmental justice. In 2012, when fracking threatened his hometown, Dominic organized more than 1,000 lawmakers that helped win New York's statewide ban on fracking, fossil fuel divestment, and nation-leading climate law, inspiring governments worldwide to act. An 11-time United Nations delegate, Frongillo and his work have appeared in more than a thousand media stories in major international news media including CNN, The New York Times, The Washington Post, Forbes, and BBC News.



#### Gary Hardie, Jr.

Dr. Gary Hardie, Jr., born and raised in Lynwood and elected to the school board at age 26, is a passionate advocate for educational equity. As a 10-year board member, he has driven change through initiatives like the Ready to Learn program, addressing students' needs outside the classroom. He created the award-winning Safe Schools Taskforce and advocated for the Department of Equity Access and Instruction. During the pandemic, Dr. Hardie started a weekly food pantry that continues to serve the community. His work with the California Association of Black School Educators (CABSE) helped remove SAT and ACT requirements for college admissions, and his advocacy at Lynwood Unified expanded access to AP courses, resulting in national recognition. At the Social Justice Learning Institute, Dr. Hardie leads community engagement and crafts policy for systemic change. Additionally, his work at Veregy focuses on sustainability and energy efficiency in schools.



#### **Torrey Harris**

Representative Torrey C. Harris is a proud community leader and advocate for Education, Children & Families and Foster and Adopted Youth in Tennessee. Representative Harris believes that everyone should be given the same opportunities to be the best they can be. Representative Harris serves in the State of Tennessee House of Representatives as the Representative for the 91st House District. Representative Harris is the first and currently only openly LGBTQ+ State Elected Official in Tennessee. Over the last decade, Representative Harris has been an outspoken voice for progressive and immediate equality, calling for discussions around what matters to those affected by the policies and laws. He is a business owner, consultant and Human Resource leader who lives by the motto that "Our prime purpose in this life is to help others, and if you can't help them, at least don't hurt them."





#### **Shelley Jackson**

Shelley Jackson is a young South Phoenix organizer, facilitator, artist, and graduate of Arizona State University with a BA in Community Advocacy and Social Policy with a minor in Dance. Her work is centered at the intersection of issue and electoral organizing with a strong focus on racial justice and a passion for empowering others to step into their power. Shelley is a Governing Board President of the Roosevelt School District, where she grew up. She ran and won at 24 years old in 2020 as a write-in candidate and has focused her service on making systemic changes for long-term impact. She is also the Executive Director of Instituto, an Arizona organization dedicated to building political power with low-income and communities of color through acceleration and incubation programs. When not organizing or tending to board duties, Shelley likes to spend time outdoors traveling, hiking, reading, dancing, and spending time with her loved ones.



#### **Dontavius Jarrells**

State Representative and Assistant Minority Leader Dontavius Jarrells is serving his second term in the Ohio General Assembly, representing House District 1, which includes portions of Columbus. Growing up in Cleveland's Hough neighborhood, Dontavius witnessed the struggles disadvantaged communities face daily, such as lack of affordable housing and limited access to education and essential services. These challenges shaped his worldview and ignited his passion for advocacy and public service. After nearly a decade of fighting for disadvantaged communities across Ohio, Rep. Jarrells is dedicated to advancing common sense legislation to improve life in Ohio. During his time in office, he passed legislation to eliminate discriminatory covenants, remove derogatory language from state code, designate January 11th as Human Trafficking Awareness Day, and secured millions for his district and Franklin County. Rep. Jarrells is committed to building the Ohio we all deserve.



#### **Brandon Johnson**

Brandon Johnson was elected to serve as Wichita's District 1 Council Member in 2017. Since taking office, he has worked tirelessly to advocate for community members while seeking economical progress for the city's northeast neighborhoods. He served on the advisory board of the Heartland Wichita Black Chamber of Commerce and currently participates as a liaison through Wichita Urban Professionals to the Entrepreneurship Task Force. Johnson is married to Danielle, who is the Executive Director for Wichita Habitat for Humanity and he has three children, Khairi, Aria and Arin.





#### **Shevrin Jones**

Florida State Senator Shevrin "Shev" Jones is an educator, public servant, and consensus builder who gets results on the issues facing Florida families. After teaching A.P. Chemistry in Broward County at Florida Atlantic University High, Jones' firsthand look at the inequities in education and society at large propelled him to enter public service. In 2012, he was elected to the Florida House, championing meaningful bipartisan legislation, including two consecutive bills to secure dignity for incarcerated women; statewide expansion of a clean syringe exchange program; safety and oversight for athletic coaches for youth athletic teams; and ensuring transparency and accountability via police body cameras. Today, Jones proudly serves Florida's 34th Senate District, which includes Northeast Miami-Dade County. Senator Jones served on President Barack Obama's College Promise Task Force and is an active member of the Alpha Phi Alpha Fraternity Inc. Today, Senator Shevrin Jones is completing his Ph.D. in Educational Leadership at Florida Atlantic University and serves on President Biden's Board of Advisors on Historically Black Colleges and Universities (HBCUs).



#### Vanessa Joseph

Vanessa Joseph is a dedicated immigration attorney based in Miami, Florida. Her journey in immigration and human rights advocacy began during her time as a law student when she engaged in legal clinics, advocating on behalf of the Haitian community in South Florida. In 2013, Vanessa contributed to an amicus curiae brief filed in the case of Benito Tide Méndez et al. v. Dominican Republic before the Inter-American Court of Human Rights, addressing human rights violations during mass deportations. At the grassroots level, she organized rallies in support of the Haitian community's rights. She currently serves as a Supervising Attorney at Catholic Legal Services, where she provides legal services to vulnerable populations. She serves as the Chair of the State Issues Committee for the South Florida Chapter of the American Immigration Lawyers Association (AILA). Her marketing and public relations company, The Creative Esquire, produces weekly radio shows on Haitian radio outlets to educate and inform the Haitian community. In 2019, Vanessa Joseph was elected as the City of North Miami's Elected City Clerk, making history as both the city's youngest and first Black female City Clerk.



#### Cleo King

Councilor Cleophus King, 7th District of Bessemer, Alabama. Cleo, a lifelong resident of Bessemer, educated in Bessemer, Cleo served his community in numerous capacities as a community activist and as a member of the Bessemer City Council. Councilor King is a fighter, He has always fought for what is right for his community. He is a leader. Just like the late Congressman John Lewis, he has gotten into trouble that was good and necessary for his community. Cleo holds a B.S. Degree in Political Science. Proud owner and C.E.O of King Enterprises, LLC. Cleo is a member and former chairman of the Bessemer Public Library Board and a member of the Jefferson County Planning and Zoning Commission. Cleo is also a former 2nd Vice President of the National League of Cities National Black Caucus of Local Elected Officials (NBC-LEO). Cleo is a member of (YEO) Young Elected Officials Network.





### **Korin Kirk**

Korin L. Kirk has served as a school board member since 2014 and is the youngest elected official in her district's history. Korin's commitment to public education stems from her own experiences as a proud product of the public school system, culminating in her college education at Buffalo State. In addition to her board duties, Korin is an advocate for community empowerment, earning her accolades such as the prestigious HYPE Award from the Greater Binghamton Chamber of Commerce and the esteemed Political Powerhouse Award at the Binghamton Black Excellence Awards in 2023. She actively participates in the New York State School Board Association's DEI committee, serves as Area 4 Director for the New York State Caucus for Black School Board Members. Korin champions equitable access to resources and power, particularly for marginalized communities, embodying the guiding principle inspired by Mary Church Terrell: "Lifting as we climb, onward and upward we go."



# **Christy Lam-Julian**

Christy Lam-Julian is 1st generation Vietnamese- American and has dedicated her life to advocating for marginalized communities. Christy's mantra is when communities are seen and heard, we all thrive. She was one of the youngest shop stewards for UNITE HERE Local 19. Teamster President James P. Hoffa made her an honorary Teamster for her work with UNITE HERE 483. She brought the Mafanikio, an afterschool tutoring and enrichment program to Shannon Elementary. She started the Pinole area chapter of Not In Our Town, Shannon Village, a people-powered movement united against hate. The City of Pinole recognized Shannon Village for organizing various multicultural representation celebrations. Christy was appointed Community Service Commissioner, the 1st Vietnamese commissioner. She was then appointed Planning Commissioner. She had served on the Kaiser Postnatal Advisory Board. Christy currently serves as Pinole Rotary Club Board member, Interact advisor, and Pinole Community Engagement Committee member.



### **London Lamar**

Sen. London Lamar has made history as the youngest female and African American legislator in Tennessee Senate history. Representing the vibrant 33rd Senate District, she champions strong schools, healthy families, and safe communities. Her legislative portfolio boasts notable advancements in economic equity for working families, maternal health, combating human trafficking, criminal justice reform, and safeguarding voting rights. She sits on several prestigious boards and has garnered recognition from national & local publications, including MSNBC, ProPublica, Washington Post, and New York Times, for her contributions. A proud alumna of Central "The" High School and Saint Mary's College in Notre Dame, IN, Senator Lamar holds a Bachelor of Arts degree in Political Science with double minors in Sociology and Intercultural Studies. She formerly served as State Representative for District 91. She is also a devoted mother to one son. As the Founder & CEO of The L2 Company, she continues to support the community through culturally appropriate business leadership and growth strategies.





#### **David LeBoeuf**

David LeBoeuf is serving his third term as State Representative for the 17th Worcester District. During his tenure, Representative LeBoeuf has successfully implemented changes to improve educational resources for foster children, forced a for-profit hospital to re-open mental health beds that were voluntarily closed during a nurses' strike, and modified high interest loans that were crippling small water systems. ## Magali Limeta

Magali Limeta is a proud first generation Mexican-American from Novato, California. She was the first in her family to graduate university and received a degree in Anthropology from the University of California, Los Angeles. She's the Senior Revenue Cycle Analyst for UCSF, an advocate for social change, and an active member of the Democratic Central Committee of Marin. She was selected for 3 fellowships including New American Leaders, Emerge California, and New Leaders Council. As the former President of the Marin County Young Democrats and current AD-10 Delegate to the California Democratic Party she has dedicated time and been recognized for her contributions to Marin County. Her passion is rooted in her struggles navigating the education system, on her own, as a first generation Mexican-American. She believes that together we can reform systems to break down the barriers to access housing, healthcare and education.



### **Jessie Lopez**

Jessie Lopez, a Santa Ana native, was raised by parents who immigrated from El Salvador in the early 1980s. Jessie's upbringing saw her attending Santa Ana's public schools, working at the Boys and Girls Club, and engaging with her community through the YMCA, the local library, and more. A graduate of Santa Ana College, she pursued a BA in Sociology at California State University, Long Beach, balancing two jobs to finance her education. During her undergraduate years, she organized campaigns addressing sexual assault on campus and advocated for higher education accessibility. Jessie's diverse professional background includes roles in law firms and nonprofits, and she bravely served as a community health worker during the COVID-19 pandemic, prioritizing the well-being of underserved individuals. In November 2020, she became the representative of Ward 3, committed to civic engagement and equal opportunities, and continues to be a strong advocate for Santa Ana families.





#### **Marcus Madison**

Councilman Marcus Madison served as a City Councilmember for five terms in Elyria, Ohio. He is the Community Relations Program Manager at the Cleveland Clinic, leading community-driven initiatives to promote healthier communities. He has over 20 years of experience in the nonprofit sector, philanthropy, local government, and healthcare, where he has demonstrated his passion and skills for community-driven initiatives, transformative leadership, and capacity building. McCarthy is a licensed graduate social worker (LGSW) in the District of Columbia and a licensed master social worker (LMSW) in Maryland. McCarthy is proud to be a first-generation college student. As a councilmember, McCarthy has been an advocate for her residents and has promoted overall positive well-being. She has hosted an Annual Vision Board Party which provides guided goal setting, a financial literacy workshop, and a mental health series to help acclimate people to the new normal post-COVID.



### Michael Menjivar

Michael was born and raised in the San Fernando Valley area of Los Angeles to immigrant parents from El Salvador. He is currently Vice President of Government Relations, Southern California, for Strategies 360, a national public affairs firm. Previously, he was the Director of Strategic Relations for the Central City Association of Los Angeles, the premier advocacy organization for Downtown LA, and also served as Deputy Director of Community Engagement for the LAUSD Board President. A UCLA graduate and alum of the 2018 Front Line Leaders Academy, Michaelhas extensive experience supporting progressive campaigns in Los Angeles. He is President Emeritus of the San Fernando Valley Young Democrats, VP of Operations for the Los Angeles County Young Democrats, Controller for the Democratic Party of the San Fernando Valley, and serves on the boards of Abundant Housing LA and the LA chapter of New Leaders Council.





# **Zaynab Mohamed**

When she was just nine years old, Zaynab and her family immigrated to Minnesota from Somalia. She grew up in a working-class household with nine brothers and sisters and two parents who worked union jobs. She attended public schools, helped raise her younger sister, and began working at a young age in order to support her family. Zaynab is a community organizer who has worked at the Minnesota chapter of the Council on American Islamic Relations, where she collaborated with community members, faith leaders, and elected officials to defend Minnesotans' civil rights. She later went on to work at Minneapolis City Hall before eventually declaring her candidacy for the Minnesota Senate. In November, Zaynab was elected to represent South Minneapolis in the State Senate at age 25 – the youngest woman to do so. She was the first-ever Muslim woman and among the first three Black women to serve in Minnesota's upper chamber. As a senator, Mohamed has focused on expanding access to affordable housing, creating economic opportunity in Minneapolis, and improving services for immigrants and communities of color.



# **Stephanie Morales**

Stephanie Morales was the first woman to be elected Commonwealth's Attorney in her city in 2015. A month after taking office, she created programming aimed at transforming the criminal justice system. She has engaged over 200 youth who she calls "Junior Commonwealth's Attorneys" under her "Future Leaders Initiative." Under her "Ctrl+Alt+Del Program" she has taught effective re-entry strategies in seminars held in the community and inside state prisons. Three months into Morales' first term an officer in her city killed an unarmed teen. Morales secured an indictment and led the prosecution at jury trial, leading to a voluntary manslaughter conviction of the officer. Morales is a 2021 Forbes: Forbes The Culture Champion Rising Star and is the 2018 Barbara Jordan Leadership Awardee. She is a fierce advocate for justice and a wife and mother of four children.



## Tram Nguyen

Tram T. Nguyen is a Massachusetts State Representative, currently serving in her third 2-year term. She is a first-generation Vietnamese-American immigrant, the first person in her family to graduate from college and law school, and the first Vietnamese-American woman elected into public office in the Commonwealth. Rep. Nguyen is the highest-ranking Asian American woman in the Legislature and champions legislation that addresses gender, racial, social, criminal, economic, and environmental justice.



### **Deli Okafor**

Deli Okafor is a first-generation Nigerian American and a lifelong resident of Baltimore, known for her commitment to public service. She holds a B.A. in Interdisciplinary Studies from the University of Baltimore and recently completed the Emerge program. Deli serves as the Vice President of Programming for the Young Democrats of Maryland, and holds other positions in different organizations. Professionally, she has been the inaugural civilian Public Relations Officer for a Baltimore City agency and the lead field organizer for the Wes Moore for Maryland Campaign, helping elect Maryland's first Black governor. Her notable achievements include introducing Gov. Wes Moore and Vice President Kamala Harris at a Baltimore GOTV rally and leading digital efforts that successfully unseated a 35-year incumbent in a separate campaign. With a proven track record of leadership, Deli is dedicated to making a lasting impact on her community and motivating others to do the same.





## **Monique Owens**

Monique Owens is a trailblazer in Eastpointe, Michigan. In 2017, she achieved a historic milestone by becoming the first black councilwoman. Monique's dedication to her community and unwavering commitment to public service propelled her to become the first and youngest black mayor of Eastpointe. Monique's passion for civic engagement and education is exemplified by her children's book, "Mom, What's A Mayor?" This book reflects her commitment to teaching the next generation about leadership and the importance of active citizenship. Her public speaking engagements reach out to women from all backgrounds and cultures, motivating them to use their voices and leadership skills to shape a better future.



### **Matt Plourd**

Matt Plourd is a lifelong resident of Newington, CT, home to the smallest naturally flowing waterfall in all of North America, and where he has long been a local organizer and advocate for youth empowerment and civic engagement. This past November, at 22, Matt was elected the youngest ever, first Latine, and first LGBTQ member of the Newington Town Council. Before being elected, Matt served as Executive Director of Sunrise Movement Connecticut, where he helped lead grassroots youth environmental justice work, including pushing passage of legislation making CT only the 2nd state in the nation to require that climate education be taught in all public schools. When not working on the Council, Matt works in the Connecticut General Assembly as a Senate Legislative Aide. He's a proud UConn Husky, music lover, and radical optimist, and is in awe of the privilege he has to give back to his hometown.



### **Channel Powe**

Channel Powe (she/her) is the Arizona State Organizing Associate for Supermajority Ed Fund. She's a prominent political activist and former school board member based in Arizona. She is known for her tireless advocacy for social justice, women's rights and educational equity and has been a leading voice in the fight for more inclusive, accountable systems. Channel looks forward to being a part of Supermajority's unyielding surge dedicated to identifying and bolstering courageous women, particularly women of color by mobilizing them to the ballot box.

In November 2019, Jasmin was elected to the Board of Education for the Roaring Fork School District. In response to the COVID-19 pandemic, Jasmin, alongside other Latino community leaders, created Voces Unidas de Las Montanas. It was the first organization of its kind in the Roaring Fork Valley, spanning three counties and more than ten cities. Jasmin was appointed by the Colorado Governor in 2021 to serve on the Early Childhood Leadership Commission, a federally authorized state advisory council for early childhood, which recently passed free universal preschool for all Colorado kids. Presently, she serves as the Vice President of the Roaring Fork Schools Board of Education, a Commissioner on the Parks and Recreation Committee for Glenwood Springs, a member of the Defiende Nuestra Tierra Advisory Board, and the Vice-Chair for the Colorado Statewide Parent Coalition. She lives in Glenwood Springs, Colorado, with her husband and two children.

Toni Rodriguez is a rising 3L at Stetson University College of Law in Tampa, FL. A second-generation Cuban American and former legislative staffer, Toni is passionate about making Florida a more affordable and progressive state to live in.



# **Amanda Sandoval-Lopez**

Amanda Sandoval, an Oklahoma native with Mexican heritage, is a trailblazer in her community. With an Associate's degree from OSU-OKC and a Bachelor's degree from Oklahoma State University. In 2019, Amanda made history as Bethany City Council's youngest and first person of color to hold the position. Notably, she received the NextGen Under 30 award and the Women Lead Award. In 2021, Amanda obtained her Master's from the University of Central Oklahoma, focusing on enhancing Latino/a/x/e voter turnout. She's also a part of LOYAL Class 16 from Leadership Oklahoma. Currently, as the Communications Coordinator for Think Again Training & Consulting and the Executive Director for La 29 / SW 29th District Association, Amanda actively promotes diversity, inclusivity, intersectionality, and equity. Moreover, Amanda serves on her sorority's National Board (Sigma Lambda Alpha Sorority, Incorporated) and the boards of La Luz Organization and the ACLU of Oklahoma. Her commitment to community engagement and social justice is unwavering.



#### **Elaissia Sears**

Elaissia Sears took office in January 2019 as Justice of the Peace for the West Mesa Justice Court. At 24 years old, she became one of just three African American women in Arizona's history to hold the position. As a judge, she focuses on implementing restorative justice techniques to reduce youth incarceration rates. Outside of her elected role, Judge Sears engages with schools and organizations to bring awareness about the court system and social issues to the community. Passionate about racial equity and access to education, Judge Sears has a multidisciplinary professional background. She has worked for the Obama Foundation, Phoenix Sister Cities, Teach For America, and the Arizona House of Representatives. Judge Sears earned a bachelor's degree in global studies from Arizona State University with a minor in German in addition to certificates in women and gender studies, international relations, and political entrepreneurship.



### **Balvir Singh**

Balvir Singh, husband, father, and public school educator resides in Burlington, New Jersey. He taught high school math for eleven years and now serves as a public school administrator. In 2014, Balvir won a seat on the local school board and served as the Chair of the Finance Committee, serving nearly 4,000 students with a budget of \$70 million. In 2016, she moved to Vermont, drawn by the state's natural beauty and the sense of genuine community. She currently works as an occupational therapist at the University of Vermont Medical Center and serves as a co-leader of the Black, Indigenous and People of Color (BIPOC) Employee Resource Group (ERG). Mary-Katherine has served the City of Burlington as an elected justice of the peace since 2020.

## **Kathryn Winsley**


