Our Vision

The Young Elected Officials (YEO) Network, a program of People For the American Way Foundation, is the first and only national initiative to provide support to the newest generation of visionary leaders at every level of elected office. It was founded in 2005 by young elected officials themselves and has since grown from a community of dozens to a national network of over 1,000 members across the country in offices ranging from local school boards to the United States Congress.

In our current political climate, we see a substantial disruption to the commonly held policies and positions across the political spectrum. This creates threats but also an opportunity. The YEO Network is uniquely positioned to seize this moment, with our diverse cohort of emerging leaders driving change and serving in leadership for their parties or their legislative bodies. We see a critical role for the members of our network to stand up for our core values and to create a proactive message and vision for the future that will resonate broadly and deeply.

Specifically, we are working with partners to create an "Alt Cabinet" of rising elected leaders who we will support and position to strategically counter the policies and rhetoric that dominate the news cycle today. While it may not replicate the official shadow cabinet used in parliamentary democracies – as we do not claim to speak for an entire movement or take up the mantle of a particular political party – we envision a next generation cabinet of innovative leaders who will begin to envision, articulate, and inspire a different future for our nation.

We will work with our members and a faculty of partners to: develop a platform of key issues, policies, positions, and messages; identify YEO members who can act as experts on these issues; and provide them with cutting edge policy briefings, messaging, and media opportunities to amplify their voices, draw attention to their local successes, and elevate their leadership.

Our goals for this initial planning meeting include:

- 1. Work with the participants to define the scope of the project
 - a. Define the role of the Cabinet
 - b. Define expectations for individual Cabinet members
- 2. Further engage Informal Advisory Group partners
- 3. Begin initial outline of the platform
- 4. Identify partners and the kinds of support they and staff will provide
- 5. Identify additional needs and resources
- 6. Envision the rollout and sketch the timeline

The YEO Network provides cutting-edge programming, investing in the full pipeline of leadership and building sustained relationships with our members. We provide the resources young elected officials need to effectively impact policy, foster their own development and professional growth, and elevate their leadership in the broader social change movement. LIZ BENNETT State Representative, IA

Liz Bennett is a state representative from Cedar Rapids, Iowa. Now serving her second term, Bennett stands for a progressive vision of Iowa which includes actively combatting climate change, assuring that Iowa's youth gets a world-class education, raising the minimum wage, using smart policy to bring needed jobs to Iowa, and working to attract and retain young professionals. During her time in the State House, Representative Bennett has established herself as an advocate for inclusion in the state of Iowa. During her first term, she has been vocal in her opposition to Islamophobia and anti-immigrant rhetoric. She is the first openly-LGBTQ woman to serve in the Iowa legislature.

Bennett is a member of the Administration & Rules, Economic Growth, Judiciary, and Ways & Means committees, and was elected as an Assistant Minority Leader of her caucus. She is a member of the Governor's STEM Advisory Council, as well as the Kirkwood Community College Liberal Arts Advisory Board. Outside the House, she works for internet company GoDaddy.



MICHAEL ALEXANDER BLAKE Assemblymember, NY

Michael A. Blake is the Assemblymember of the 79th District in the Bronx, New York, representing parts of Concourse Village, Morrisania, Melrose, Belmont, Claremont, and East Tremont. He is passionate about urban entrepreneurship, Minority and Women Owned Business Enterprises (MWBEs), education, community learning, building sustainable communities, equality for all, and empowering young men of color. Assemblymember Blake serves on the Correction, Housing, Election Law, Governmental Operations, Banks, and Veterans Affairs committees and is the Chairman of the Mitchell-Lama (Affordable Housing) subcommittee. Assemblymember Blake, in his first year in office, was elected the 2nd Vice-Chair of the NY Black, Puerto Rican, Hispanic and Asian Legislative Caucus. Blake's work continues in the

community. Blake serves on the My Brother's Keeper Alliance as a national advisory board member (the only state legislator in the nation) and is a board member of iVOTE, which focuses on protecting voting rights across the country. He previously served as the senior advisor for Operation Hope and is the founding principal of Atlas Strategy Group, which focuses on political and economic empowerment for communities of color. In February 2017, Blake was elected Vice Chair of his national party committee.



CRISANTA DURAN Speaker of the House, CO

In November 2016, Crisanta Duran was unanimously voted as the 58th Speaker of the Colorado House of Representatives, one of the top three positions in state government. She is the first Latina Speaker of the House. At the age of 36, she is beginning her fourth and final two-year term representing House District 5 in central Denver, and earlier in 2016 she was a featured speaker at the National Convention for her party. Speaker Duran has been a leader in legislative economic development efforts. As the House Majority Leader in the 2015 and 2016 sessions, she coordinated and marshaled strong bipartisan support for the legislative package known as Colorado Ready to Work — more than a dozen new laws to boost Colorado businesses and train Coloradans for the good-paying, highly skilled jobs our growing,

modernizing economy is producing.

Before being elected to the caucus leadership, Duran was chairwoman of the legislature's powerful Joint Budget Committee. The 2014 state budget drafted by the Joint Budget Committee was notable for its significant increases for K-12 and higher education and funded a variety of measures to boost the state's economy and increase the economic security of Colorado families. Duran serves on the board of the National Association of Latino Elected & Appointed Officials and the national Board of Hispanic Caucus Chairs. In 2016 she won the national EMILY's List Rising Star Award, given annually to "an extraordinary woman serving in state or local office." She is a sixth-generation Coloradan with a law degree from the University of Colorado. Her bachelor's degree is from the University of Denver, where she was a double major in public policy and Spanish.



MARY E. GONZÁLEZ State Representative, TX

In November 2012, Mary E. González was elected State Representative for House District 75. González was raised in Clint, Texas. She serves on the Appropriations Committee and is Vice Chair of the Agriculture and Livestock Committee in the Texas House. Throughout her time as a state representative, she has authored numerous bills to improve public schools, increase economic development, advocate for social justice, and support agriculture across Texas. She is currently serving her second term as Treasurer for the Mexican American Legislative Caucus and was elected Secretary of the House Border Caucus. As a result of her accomplishments, she was named "Freshman of the Year" by the Mexican American Legislative Caucus, a "Champion of Equality" by Equality Texas two sessions in a row, and the 2015 "Advocate of the

Year" by the same organization. In 2015, she was the youngest inductee into the El Paso Women's Hall of Fame.



MATT HANEY Board of Education, San Francisco, CA

Matt Haney is a Commissioner on the San Francisco Board of Education and the immediate past president. Throughout his career, Haney has fought to close the racial opportunity gap and is a national leader in working to end the school-to-prison pipeline and expand education in computer science. In 2016, Haney was the only school board member in the country endorsed by President Barack Obama and received the most votes of any candidate for school board in San Francisco history. Haney is National Policy Director at Dream Corps, where he leads the organization's broader political and policy strategy to close prison doors and opens doors of opportunity. Haney has a BA from UC Berkeley, an MA from Stanford University School of Education, a JD Stanford Law School, and an LLM in Human Rights from

National University of Ireland. He previously served as Adjunct Faculty at the Stanford Design School.



DANIEL HERNANDEZ JR State Representative, AZ

Daniel Hernandez is an Arizona native. He is the 2015 Tucson Hispanic Chamber of Commerce "40 under 40 Man of the Year." As a first generation college student, he was a congressional intern for the office of former Congresswoman Gabrielle Giffords of Arizona. While assisting Congresswoman Giffords with a constituent event in Tucson on January 8, 2011, Hernandez took actions for which he is widely credited with saving the life of the Congresswoman after a gunman shot her and 18 other people.

He was elected to the Sunnyside Unified School District Governing board in November 2011 and most recently served as president of the board. In that role, he was successful in creating a five-year strategic plan, opened a new K-8 fine arts

magnet school, hired a new superintendent, accomplished comprehensive sex education and secured grant funding to implement it.



JON HOADLEY State Representative, MI

Jon Hoadley is in his second term as the representative for the 60th House District, which includes Kalamazoo and portions of the city of Portage and Kalamazoo Township. Representative Hoadley is a small business owner and serves as president and owner of Badlands Strategies, a progressive public affairs firm. Previously Hoadley served as Executive Director of National Stonewall Democrats, worked for the Gill Action Fund, and managed South Dakotans Against Discrimination. In the community, Hoadley serves on the board of Mothers of Hope, the advisory committee to the National LGBTQ Task Force, the National Caucus of Environmental Legislators, the steering committee of the American State Legislators for Gun Violence Prevention, the National Conference of State Legislators Elections

Task Force, and volunteers at his church, First Congregational Church-United Church of Chris. In his first term, Hoadley served on the House Appropriations Committee as a vice chair of the Judiciary and Agriculture subcommittees, as well as on the Higher Education subcommittee. He also served on the House Elections Committee.



PAULETTE JORDAN State Representative, ID

Paulette Jordan is an Idaho House Representative and member of the Idaho Legislative Council. Representative Jordan holds a seat on the State Affairs Committee, Resources and Conservation Committee and Energy, Environment and Technology Committee. Jordan has been involved in Tribal and State political matters for over 15 years. Prior to her election in to the Idaho House, she just completed her third year as an elected member of the Coeur d'Alene Tribal Council. Jordan was appointed to represent Idaho on the Energy and Environment Committee of the Council of State Governments-West, a legislative organization that is comprised of 13 states in the western region. Additionally, she is appointed to serve as the Idaho Representative to the Idaho Advisory Committee to the U.S. Civil Rights Commission,

the Criminal Justice Oversight Committee, the Idaho Indian Affairs Council, and the Joint-Economic Outlook Committee.

In the private-sector, Jordan was elected to serve as the Executive Secretary of the National Indian Gaming Association, where she retains her position as Finance Chair and the Energy Initiative Chair of the Executive Board.



JANE KIM Board Supervisor, San Francisco, CA

Jane Kim is a member of the San Francisco Board of Supervisors. She serves as Chair of the Government Audit and Oversight Committee and is a member of the Transbay Joint Powers Authority, San Francisco County Transportation Authority, Budget and Finance Committee, Metropolitan Transportation Commission, and the Treasure Island Mobility Management Agency. Prior to being a San Francisco Supervisor Jane Kim was a community organizer at Chinatown Community Development Center, a civil rights attorney at Lawyers Committee for Civil Rights, and served as President of the San Francisco Board of Education. She received a dual B.A. in Political Science and Asian American studies from Stanford University and her J.D. from the U.C. Berkeley School of Law. Kim has built a strong base of

support throughout her community activism and time in office. Her approach to policy making is values-based and prioritizes community-building and progressive leadership development. Kim has developed a reputation as someone who will fight for everyone in the district - in particular, those who too often do not have a voice in our government.



CHRIS LARSON State Senator, WI

After defeating an incumbent from his own party during the 2010 fall primary, Chris Larson was elected to the Wisconsin State Senate at the age of 29.

Larson was one of the 14 Senators who bravely left the state in February 2011 to stand up for the rights of workers, giving them a voice in the legislative process when the governor was trying to shut them out. Just two years later, he was elected to serve as Senate Leader for his party during the 2013-2014 legislative session. He was one of the youngest senate leaders in Wisconsin history. Larson is a leading voice on education issues and has a strong background in finance, progressive messaging, transportation, energy policy, and environmental issues. Previously, Larson was a Milwaukee County Board

Supervisor. He is married with two children. In his downtime, he trains for marathons and is on his way to running one in each of the 50 states.



MATTHEW LESSER State Representative, CT

Matthew Lesser is serving his fifth term in the Connecticut House of Representatives, where he is House Chair of the Banking Committee. Lesser authored Connecticut's first-in-the-nation Student Loan Bill of Rights and has received national recognition for his work on retirement security, consumer financial protections, election and campaign finance reform, and the environment. In 2015, Lesser was the recipient of a Marshall Memorial Fellowship from the German Marshall Fund of the United States.



NATALIA D. MACKER County Commissioner, Teton County, WY

Natalia D. Macker is the Vice Chair of Teton County Board of Commissioners, where she works diligently to maintain the equality, vibrancy, and diversity of her community. She is a co-chair of the health and safety committee at the Wyoming County Commissioners Association and serves on the Health Committee and Rural Caucus at NACo. Her record demonstrates support for women and working families and a commitment to public lands, sustainability, and conservation values. She was appointed in 2015 by Governor Matt Mead to serve on the Land Quality Advisory Board for the Wyoming Department of Environmental Quality. Previously, she was appointed twice to the Teton County/Jackson Parks & Recreation Advisory Board. Born and raised in Knoxville, TN, she is a graduate of the Front Line Leaders Academy and a

member of the Young Elected Officials Network. Macker holds a BA cum laude from Yale University.



DOMINICK MORENO State Senator, CO

Born and raised in Commerce City, Dominick Moreno grew up going to public schools where he made valedictorian while working afternoons at the local Dairy Queen. Through scholarships and part-time jobs, Moreno attended Georgetown University and graduated with a degree in American Government. Moreno's commitment to using his education to benefit his community led to his election to the city council in Commerce City at the age of 24.

Moreno is committed to making sure hunger is not a learning disability in Colorado. He has successfully passed bills to require universal breakfast in all low-income schools and to help families pay for the cost of providing school meals for their children. Moreno was elected to the Colorado Senate in 2016. He previously served in the Colorado House of

Representatives for two terms. He is a member of the Joint Budget Committee, a six member committee charged with crafting the state budget each year.



ADAM MORFELD State Senator, NE

Senator Adam Morfeld was elected to the Nebraska legislature in 2014 and is a member of the Judiciary and Education Committees. He is the third youngest member of the legislature and represents downtown and Northeast Lincoln.

Morfeld graduated from the University of Nebraska-Lincoln with a BA in Political Science and earned his Juris Doctorate from the University of Nebraska-College of Law in 2012 and was a member of the Nebraska Law Review. He specializes in voting rights and non-profit administration and compliance. While an undergrad in 2008 he founded and continues to serve as the Executive Director of Nebraskans for Civic Reform (NCR), a non-partisan, non-profit organization that engages youth through substantive community service and leadership programs in schools, and ensures

elections are accessible for youth, low-income people, people with disabilities, and seniors through voting rights investigations, litigation, research, and policy advocacy. With a full and part-time staff of 30, NCR works to create a more modern and robust democracy for all Nebraskans.



ILHAN OMAR State Representative, MN

Ilhan Omar is the newly elected Minnesota House Representative for District 60B. She is the first Somali-American, Muslim woman in the nation to hold an office at this level. Omar is an experienced policy analyst, progressive activist, coalition builder, and humanitarian. Most recently, she served as the Director of Policy Initiatives at Women Organizing Women, where she empowered East African woman to take civic leadership roles in their community. Omar lives in the West Bank neighborhood of Minneapolis with her husband and their three children. Committed to unity and justice, Omar is focused on advancing important issues, including raising the minimum wage to \$15/hour, closing the opportunity gap, and fighting for environmental justice and racial equity. Omar holds degrees in Business

Administration, Political Science, and International Studies. She completed a Policy Fellowship at University of Minnesota's Humphrey School of Public Affairs. She has also served on numerous nonprofit boards including the Legal Rights Center, YMCA, and Confederation of Somali Community of MN. She is currently the Vice president of the DFL Feminist Caucus. Omar has received multiple accolades and awards, including the Rising Star Award from a Women's Hall of Fame and a Community Leadership Award from the Mshale Newspaper for outstanding leadership.



DAN RAMOS State Representative, OH

Dan Ramos has served in the Ohio House of Representatives since 2011, after having served as a legislative staffer beginning in 2000. Ramos has fought for equal rights, labor rights, working people, students, seniors, and the poor. He has been Ranking Member on the Higher Education Finance Committee where he has fought for true college affordability. He has been instrumental in passing legislation to save state pensions and legalize medical marijuana. Ramos is currently the longest serving Latino state official in Ohio history. Ramos resides in his hometown of Lorain, Ohio.



AARON REGUNBERG State Representative, RI

Aaron Regunberg is a progressive member of the Rhode Island House of Representatives, representing the 4th District in Providence. Regunberg comes out of community organizing. In 2010 he co-founded the Providence Student Union, a youth-led public school student advocacy organization that has won campaigns around issues including ethnic studies curricula, infrastructure repairs, free student bus passes, and an end to school closings and high-stakes testing. In 2014, Regunberg was elected to serve Rhode Island House District 4 on the East Side of Providence. During his first term as state representative, he introduced and passed legislation raising Rhode Island's tipped minimum wage, establishing online voter registration, and creating new renewable energy programs. He has led fights in Rhode Island to guarantee

earned paid sick days, create a state-level carbon pricing system, reform solitary confinement, and establish a more progressive tax system, among other proposals. Regunberg graduated magna cum laude from Brown University with a B.A. in Political Science. He lives on the East Side of Providence with his fiancée and their two cats, Langston and Myles.



DANIEL RIEMER State Representative, WI

Currently in his third term, Daniel Riemer was first elected to the Wisconsin State Assembly at the age of 25. He is committed to reforming Wisconsin's economy, health care system, and schools to provide better opportunity for all Wisconsinites. For two consecutive sessions, Riemer has authored bills to expand Wisconsin's supplement to the federal government's Earned Income Tax Credit, one of the nation's largest and most effective anti-poverty programs. Riemer has also authored bills that would increase access to the state's Medicaid program for tens of thousands of Wisconsinites. Riemer has served on the Assembly committees on health, ways and means, workforce development, and veteran's affairs. Riemer is a Wisconsin native and graduate of the University of Chicago and University of Wisconsin-Madison

law school. Before entering politics he wrote for The Guardian. He remains a frequent editorial contributor to papers across the state.



NATALIA RUDIAK City Councilmember, Pittsburgh, PA

Natalia Rudiak, a two-term city council member, was born and raised in South Pittsburgh, where she is a proud graduate of Pittsburgh Public Schools' Carrick High School. She went on to earn her Bachelor's Degree from George Washington University and the London School of Economics through scholarships awarded from the AFL-CIO before completing her graduate degree at Carnegie Mellon University.



BRANDON M. SCOTT City Councilmember, Baltimore, MD

Brandon Scott was sworn in as City Councilman for the 2nd District on December 8, 2011. Elected at the age of 27, Brandon is one of the youngest members ever elected to the Baltimore City Council. Scott has been very busy during his first term on the council keeping promises he made on the campaign trail. He has led legislative initiatives that created extensive crime data sharing and online reporting of crimes by the Baltimore Police Department. Moreover, Scott has reinstated Council Oversight of the police department by holding quarterly hearings to make sure the police department is working for Baltimore's citizens. In addition, Scott passed legislation that updated and made sense of Baltimore's decades old youth curfew law in 2014. Scott has work diligently alongside residents and business owners to

foster the redevelopment of the Belair Road corridor. He was able to secure funding for a critically important market study and over a million dollars for infrastructure improvements. In 2016, Scott led the way as the City Council passed monumental legislation to create restaurant inspection transparency in Baltimore. Brandon serves as the Chair of the City Council's Public Safety Committee and is a member of the Budget and Appropriations and Judiciary and Legislative Investigations Committees. He is the co-founder of the 300MenMarch anti-violence movement. Scott lives in Baltimore's Frankford Neighborhood.



MARY SHEFFIELD City Councilmember, Detroit, MI

In her community, Mary Sheffield is a native Detroiter with a demonstrated track record of service and leadership in our community. Following in her father's footsteps, Rev. Horace L. Sheffield, Sheffield was ordained as a minister and is very active in her ministry. In November of 2013, Sheffield became the youngest person ever elected to the Detroit City Council at the age of 26. Elected to serve in District 5, Sheffield was appointed as Chair of the Neighborhood and Community Services Standing Committee and also serves as a member of the Planning and Economic Development Standing Committee. At the Council table, Sheffield has made a commitment to fight for the continued growth of our city and has remained steadfast in keeping our neighborhoods at the center of the conversation.

In Sheffield's short time on the Detroit City Council, she has launched a number of initiatives designed to engage residents and offer a truly representative form of government to the residents of District 5. Some of her most groundbreaking initiatives include, but are not limited to, her monthly "Conversations with the Councilwoman" series, Occupy the Corner - Detroit, Neighborhood Angels Program, Homelessness Taskforce, and a monthly e-newsletter.



SPENCER THIBODEAU City Councilmember, Portland, ME

Spencer Thibodeau currently serves on the Portland City Council. His work ethic and desire to serve others led him to major in Political Science at Fairfield University, where he fell in love with politics. Inspired by Barack Obama's historic primary campaign, Thibodeau spent the summer of 2007 organizing volunteers in New Hampshire. This experience yielded an opportunity to spend the summer in Washington, D.C. as an intern for Congresswoman Pingree. Thibodeau attended law school at Northeastern University School of Law, where he clerked at the Massachusetts Land Court, served as a legal intern at the United States Attorney's Office for the District of Maine, and worked on environmental issues at the Conservation Law Foundation. After graduating from Northeastern, Thibodeau returned to Portland to

practice law. Thibodeau has taken full advantage of the newest "Foodie City" and when he is not working, you can find him reading at a local coffee shop, running, or grabbing dinner with friends.



FAITH WINTER State Representative, CO

Representative Winter was active on a variety of issues in the 2016 legislative session, introducing bills to encourage equal pay for equal work, as well as bills to boost renewable energy in Colorado and promote affordable housing across the entire state. In the 2015 session, she sponsored a key component of the Colorado Ready to Work jobs package — a bill that allows high schools to provide coursework that will count toward graduation and toward apprenticeship programs in high-demand professions. Winter was elected to the legislature after seven years on the Westminster City Council, where she helped to make Westminster the first platinum solar city in the state. Dr. Colin Greer has been the President of the New World Foundation since 1985. Formerly, he was a professor at Brooklyn College, CUNY. He wrote briefing papers on philanthropy and government for First Lady, Mrs. Hillary Clinton, and on education policy for Senator Paul Wellstone. He chaired the President's White House Internship Financial Aid Committee (1992-4) and chaired the Funders Committee for Citizen Participation (for 12 years).

His books include (with Herbert Kohl) A Call to Character and The Plain Truth of Things. Other books include, with Frank Riesman and Alan Gartner, What Nixon is doing to Us and After Reagan What? He is best known for The Great School Legend and Choosing Equality: The Case for Democratic Schooling (which won the American Library Association's Eli M. Oboler Intellectual Freedom Award). He was a founding editor of Change Magazine and Social Policy Magazine. He was a contributing editor to Parade Magazine for 17 years. His best-known interviews were with Mikhail Gorbachev, Billy Graham, and Bishop Desmond Tutu.

He chairs the Boards of the LARK Play Development Center and the Stella Adler Studio of Acting. He also serves on the Boards of Alternet, New York City Interfaith Center, and *Tikkun Magazine*. He formerly served on the Boards of Teachers and Writers Collaborative and openDemocracy USA.

Colin Greer also writes non-fiction. His poems have been published in *Transformations* and *Hanging Loose*. Two of his plays, *Imagining Heschel* and *Spinoza's Solitude*, are collected in *Religious Differences Between Artichokes* (Lantern Books) with a Preface by Cornel West. SVANTE MYRICK* Alt-Cabinet Project Chair

Svante L. Myrick was sworn into office in January 2012 and became, at 24, the City of Ithaca's youngest mayor and first mayor of color. Myrick was first elected to the Common Council at the age of 20 while still a junior at Cornell. His first budget included a radical overhaul of City government that merged departments, streamlined processes, and was able to successfully close a \$ 3 million deficit – all while delivering the lowest tax increase in the City of Ithaca since the year 2000. His active advocacy in Albany and in Washington, D.C. has resulted in over \$30 million of grants and awards from the state and federal government. Myrick has changed the way people in Ithaca view public space by turning his dedicated mayoral parking space into a public park and he's moved Ithaca into the 21st century by embracing social

media and overhauling the City's web presence. His accomplishments include successful implementation of the total rehabilitation of the Commons, Ithaca's downtown pedestrian mall, and making changes within the Ithaca Police Department in an effort to improve police and community relations. In 2015 he ran and won another four year term as Mayor, leading with a commanding 89% of the vote. In 2016 Myrick released "The Ithaca Plan - A Public Health and Safety Approach to Drug Policy" which gained international attention for its forward-thinking policies and vision. Myrick has also gained accolades for welcoming refugees from war torn regions of the world to Ithaca.



GREG NELSON*

Greg Nelson runs business operations and strategy for Parker Media and the Sean Parker Foundation, and is a Fellow with the Aspen Institute's Future of Work Initiative. Nelson spent six years at the Obama White House as a senior leader in the economic policy, clean energy, technology, and strategic partnerships teams.
